### OFFICIAL RULE

All entries become the sole and exclusive property of the Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.
4. **Winner Selection.** All Qualifiers will be notified and must be present at River Valley Orchards and Winery located at 1645 220<sup>th</sup> St, Humboldt Iowa on Saturday October 8th, 2022, at 3pm.
